CONFLICT OF INTEREST POLICY

FAME is committed to ensuring that its Staff and Board of Director have an open and productive environment in which to further the mission of the organization. Conflicts of interest, in the most conventional sense, arise because Staff or Board Members may have the opportunity to influence FAME's decisions in ways productive of personal gain.

It is the policy of FAME that:

- its Staff or Board Members have an obligation to disclose any practice that may conflict with their obligations to FAME or its welfare;
- any Staff or Board Member engaging in an outside activity or possessing a personal interest that could lead to a conflict of interest must inform FAME of that possibility by consulting with the Executive Director or Chairman of the Board;

IMPLEMENTATION OF THE POLICY:

FAME is committed to the implementation of the Conflict of Interest Policy by providing for:

- 1. Disclosure of all relationships that may result in conflicts by persons subject to the policy;
- 2. Readily available counsel and advice regarding all conflicts; and
- 3. Fair and equitable application of the Policy to all Staff or Board Members.

In order to implement this policy, all Staff and Board Members are required to annually complete a Conflict of Interest Policy Disclosure. The requested disclosure attempts to balance FAME's needs for information with the individual's reasonable expectation of privacy in his or her personal affairs. No information about financial arrangements need be provided. Should you need guidance in preparing your form, please contact either the Chairman of the Board or the Executive Director.
